# 2022 Rung Pigeons Not Rung with a PRF Ring

All flyers who have young birds rung with rings other than PRF rings, and wish to fly them in the Federation Young Bird Derby, must submit ring particulars to PRF Treasurer, John Wintle, on a **Flyer Life Ring Registration List 2022**, at a cost of .10 cents per pigeon. This form is available from your club Secretary.

Members are reminded that the .10 cents, is not a transfer fee but goes toward prize money, 50% for the Federation YBD and 50% towards the two long Federation races.

Nominations are required to be with the Federation Treasurer by 1 May, 2023. Under the provisions of our Constitution nominations after that date are \$10 per bird.

For reference covering these requirements in the Constitution 5, 8.3, 8.4, 8.5.

Note, to qualify for Federation (positions, prize money) any rings (Legacy, Sires, birds gifted) not issued to you by your club, the Federation should be notified in writing as above. This also greatly assists the Lost Bird Officer, who has also expressed consideration that a person gifting birds to another, provide a letter / email, confirming details of the birds, (Ownership transfer singed by club Secretary) to that person, to be forwarded with the ring list.

#### Nominations for 2023 Federations Sires

The treasurer is currently accepting nominations for the 2023 Federation Sires Race. Nominations must be with the Treasurer by the second race of the season. Nomination fee \$10 per pigeon. Nomination form is available from your club Secretary.

## **Register of Members**

To be updated by Federation Secretary. This is a work in Progress. Secretary has asked that the club Secretaries / President forward an updated club membership list to the Federation Secretary; this should contain: Racing Name / Flyers names / Mobile No / Home No / Email Address / Physical Address. A blank document has been attached which may assist.

#### **Events Calendar**

For ease of reference by members and to avoid special events clashing, Clubs are again requested to advise the Board of any special events due in the coming season, for example, Sires, Legacy auctions or other special event.

#### **Labels on Federation Crates**

In order to ensure every club is adequately catered for, no club is to load a Federation crate onto the truck unless it bears the appropriate club label, as per the Constitution.

Each member is entitled to one [1] crate only per week. For example, if you have 10 members, only ten crates are eligible to be loaded onto the Federation truck by your club.

In the event of a complaint, if a member is compliant with local By-laws he/she should survive the complaints process, if not compliant it is very difficult to assist them.
